VATI APPLICATIONS

As detailed in the 2020 Virginia Telecommunication Initiative (VATI) program guidelines, DHCD will post electronic copies of all submitted applications to the agency website within 5 business days after the application deadline. Any private sector service provider wishing to request that DHCD deem a proposed project area as ineligible for VATI must submit a challenge with the information required in the Challenge Process section, no later than 5:00 pm on October 9, 2019. DHCD will have 30 business days to validate a challenge. Applicants will be notified if their proposed project area is being challenged. Applicants will have 15 business days from notification of a challenge to provide any additional information to DHCD. Please send challenges to vati@dhcd.virginia.gov




